### **DECLARATION OF DIVE/TRAINING PARTICIPANT**

*(To be given before starting water activity)*

With the signature on the reverse side, each diver participating in the dive/training session testifies and declares the following:

- 1) that the guide/instructor has held/will hold a pre-dive briefing, explaining the intent of the dive/training session, the environment in which the dive/training session will be carried out, the activities to be done in the water, the possible problems and dangers, the emergency procedures and the facilities to be used in case of emergencies;
- 2) **in the event that the pre-dive briefing has been carried out before the signing of this form:**  
to have listened to the pre-dive briefing and reaffirmed the will to participate voluntarily in the dive/training session;
- 3) **in the event that the pre-dive briefing hasn't been carried out before the signing of this form:**  
to communicate immediately to the guide/instructor that having listened to the pre-dive briefing, one doesn't feel ready or able to participate in the dive/training session;
- 4) **in the event of free/recreational dive:**  
to possess certification relative to the level of the dive, (in the case of specialist dive) to have necessary experience, registered in the own log book, or self-certified with the signature present on this form;
- 5) **in the event of training session:**  
to participate in the various stages necessary for obtaining certification, or to improve own skills relative to courses already done;
- 6) to have medical certificate relative to this activity;
- 7) to feel physically and mentally prepared for the participation of the dive/training session;
- 8) to not be in situation that could prevent or hinder, even temporarily the dive/training session, especially:
  - a) to be in perfect physical condition;
  - b) to not have eaten (or consumed alcohol) for at least 3 hours previously;
  - c) to have the necessary equipment for the intended activity;
  - d) to feel completely at one's ease with these equipment;
  - e) that the ones personal equipment is in optimal condition;
  - f) that the diving centres' equipment is in optimal condition;
- 9) to commit oneself to respect all instructions given by the guide/instructor before, during, and after the dive, especially not to exceed ones' limits;
- 10) to take full responsibility for accidents incurred, either from breaking rules, not respecting common safety regulations known to all scuba-diver, disregarding pre-dive arrangements established by the guide/instructor, disregarding the declarations made on this form, making false testament, in the knowledge that the diving centre/school can take the necessary legal action;
